## About SPD

We are a charity that helps people of all ages, who are born with or have acquired disabilities, lead enriching and fulfilling lives.



## Message from President

FY2017/2018 was another fulfilling year for SPD. We continued to make headway in enabling and empowering people with disabilities and their loved ones. But our work is only possible because of the generosity, dedication and enthusiasm of our supporters – companies big and small, as well as individuals from all walks of life, whose kindness have given hope to many and transformed their lives.

Within these pages, we feature some of them along with the people whose lives they have touched. We hope their contributions and the impact we have made together will inspire even greater support and increase interest in our work.

In the year, we set out to improve lives and promote acceptance of people with disabilities in the community, and we would like to believe we achieved more than some measure of success.

In all, our programmes and services catered to 9,400 persons with disabilities. We stood behind 1,200 children and youths with therapy, learning and educational support, giving them the confidence to dream big and reach for the brightest stars. We offered 300 training places to increase the employability of persons with disabilities finding jobs, and we were there to rejoice with over 200 individuals when they found financial independence through our job support services. We took comfort that nearly 500 adults and elderly could stay home with the step-down care provided at our rehabilitation centres, and that 300 families were supported through the respite care service that we operated. We introduced assistive technology to 300 individuals and changed their lives. We also rallied and empowered over 1,600 caregivers, and called for greater acceptance in schools, at the workplace and in the community by reaching out to 17,000 individuals.

We pushed the envelope to innovate, to try to do more with less. We leveraged technology in the classrooms, tried new initiatives including our first virtual run and charity dinner to reach out to previously untouched segments of the community, and we stepped out of our comfort zones to review how best our clients could be supported.

That said, there's more work ahead for us. The demand for disability support will grow as Singapore prepares for its 'silver tsunami', not forgetting that increasingly more children are also diagnosed with some form of developmental needs. The SPD Vision 2020 strategic roadmap was formulated to take us forward to year 2020, focusing on the client, organisational and societal levels. We are working towards creating greater opportunities for people with disabilities, strengthening our capabilities to provide impactful services and focusing on advancing the interests of persons with disabilities through greater collaborations in the community to achieve an inclusive society.

Lastly, the Board and I would like to thank all our supporters as well as the management and all staff of SPD who always give their best at work every day. And we are grateful to each and every one of you who have supported us with your time, money and expertise. Let's continue to work together to ensure that no one is left behind because of their disabilities.



## Creating brighter futures for our children

### EARLY INTERVENTION SUPPORT

SPD runs three early intervention programmes – the **Early** Intervention Programme for Infants and Children (EIPIC), the Development Support and Learning Support (DS-LS) and the Continuing Therapy Programme (CTP), helping children and youths with special needs below 18 years old.

The EIPIC and CTP are centre-based programmes while the DS-LS teams in Jurong and Tampines go to the children's preschools and support them in their natural learning environment.

With greater capacity, the four Building Bridges EIPIC Centres served 535 children, 13 per cent more than the previous year. CTP, which provides speech and occupational therapy, served 206 children under 18 years old. This was 11 per cent more than year before. Fees for DS-LS packages were revised in the year, and we served 322 children, a slight dip from last year.

The first phase of the online pre-school management system was launched to help EIPIC teachers streamline administrative processes. When extended to caregivers the following year, it would facilitate communication between staff and caregivers. Caregivers will be able to use it to keep tabs on their child's progress and access useful resources via the portal.

Children graduating from EIPIC joined Primary 1 students from Zhangde Primary School in class and during recess in an immersion programme. Parents were also briefed on what they could expect and how they could help their child transit to primary school.



### Ridhwan Jacob Bin Irwan EIPIC Client

Ridhwan Jacob Bin Irwan was diagnosed with Autism Spectrum Disorder and had frequent meltdowns that caused disruption in his daily activities. At her wit's end, his mother, Mdm Racquel, enrolled him into SPD's Building **Bridges EIPIC Centre in** Bedok. The team of transdisciplinary professionals, including teachers and therapists, worked with Mdm Racquel to plan the best intervention strategies for Ridhwan. She has since seen huge improvements in the 5-year-old who is now able to follow instructions and perform daily activities with guidance from his teachers. Mdm Racquel is grateful for the care shown towards Ridhwan, and looks forward to seeing her son improve further.

### EDUCATIONAL SUPPORT

Recognising that a good education could be the game-changer for our youngsters that would broaden their career options, we work harder to help level the playing field and provide the support they need in school.

The **SPD Education Programme** offers students with disabilities in mainstream schools, from primary to tertiary levels, a holistic support that encompasses bursary, learning opportunities, resilience training and tuition support.

Sponsored by NatSteel Holdings, the number of bursaries awarded to students in institutes of higher learning was higher than before. We also gave out the SPD Youth Aspiration Award to three youths to pursue community service, music and sports. Mohamed Najulah Bursary Recipient

The bursary given out under the SPD Education Programme has supported Mohamed Najulah in his studies from secondary school through polytechnic and then university. The undergraduate at the Singapore Management University, who was born with brittle bones, is working towards becoming a software developer. He wants to develop applications that would help persons with disabilities.

The Microsoft YouthSpark Scholarship and Asia Pacific Breweries (APB) Foundation Scholarship for Persons with Disabilities, which are both bond-free, are administered by SPD. Three new students were awarded the APB Foundation scholarship in September 2017.

An alumni club was set up to build camaraderie among former and current scholarship recipients and to nurture a give-back ethos.

### LEARNING OPPORTUNITIES

**Coding Quest,** a year-long programme sponsored by Microsoft Singapore and introduced in December 2017, imparted digital literacy skills in web coding, design, game creation and development of e-stores to about 30 youths with disabilities between 13 and 39 years old.

Team Alluvial's social inclusion project was picked as the winner of the year-long mentorship and training programme – **SPD Youth Development Programme.** Through simulation activities, team members Teo Zi Lin and Joshua Ong enabled secondary school students to experience daily life as a person with visual impairment.

### EMPLOYMENT SUPPORT SERVICES

The **Employment Support Programme (ESP)** helps persons with disabilities find work and provides them with the financial means to support themselves and their families. Courses are also conducted to help them improve their employability.

### Ng Xian Min ESP Client

Ng Xian Min was diagnosed with brittle bones disease when she was young and has been using a manual wheelchair to move about. Due to her disability, Xian Min could not take up work that involves manual labour. Through the ESP, she signed up for courses to improve in her resume writing, job hunting and interview skills. The training boosted her confidence in handling job interviews, and she was successfully placed in a cashiering role at a pet shop. In the initial months, our employment support specialist and occupational therapist were there to ensure that she integrated well into her new work environment. Xian Min told us that she enjoys her job very much.

### SUPPORTED EMPLOYMENT

For those found unsuitable or not yet ready for open employment, the **SPD Sheltered Workshop** provides training in a supported employment setting.

Social workers conducted social etiquette training to prepare trainees for open employment. Mobility training in the community was also conducted so that trainees could learn to commute independently and integrate better in the community.

### TRANSITIONAL SUPPORT

**Transition to Employment** (TTE) is a community-based returnto-work programme aimed at reintegrating people with acquired physical disabilities back to the mainstream workforce through a trans-disciplinary and clientcentred approach.

The programme previously called Transition Programme for Employment expanded to admit those with other acquired disabilities besides spinal cord injuries and stroke. Yuen Lai Yee Sheltered Workshop Trainee


Yuen Lai Yee, a stroke survivor, joined the Sheltered Workshop after she was discharged from the SPD Rehabilitation Centre. At the workshop, Lai Yee, 41, received regular oneon-one community mobility training conducted by an occupational therapist. The encouragement of the social workers also motivated her to press on. Her confidence grew with familiarity of the work processes and the training that she received. Lai Yee was selected as one of the 15 trainees to be seconded to a customer's warehouse. With the support of the Sheltered Workshop programme, Lai Yee is a step closer towards returning to open employment.

### Muhammad Haikal Johari

Muhammad Haikal Johari is an executive chef who was previously based in Bangkok. A motorcycle accident in 2015 left him partially paralysed from the shoulder down. His wife became his main caregiver and he needed to re-learn even the most basic activities like walking and grasping onto items. Months of therapy later, Haikal went on to become part of the team that helped a local Spanish restaurant earn a Michelin star. At the TTE, SPD's transdisciplinary team continue to help Haikal build up capabilities he requires for his work in the kitchen. Our employment support specialists also helped with the workplace accessibility assessments when Haikal was planning for his own fine-dining restaurant which opened in early 2018 to many positive reviews.

## Improving community care

### **RESPITE CARE SERVICES**

The **Day Activity Centre (DAC)** located within SPD Ability Centre is a day care facility for people with physical and multiple disabilities. Here, the clients are trained in activities of daily living as well as social skills. Caregivers also receive respite and are able to continue working with peace of mind.

Day care programmes are also available at SPD@Toa Payoh, which has one incorporating day care and active therapy.

### Lim Yu Ann DAC Client

Having been diagnosed with congenital cerebral palsy, Lim Yu Ann requires supervision and uses a quadstick for long distance travel. After a working stint that went south due to anxieties being in a work environment, Yu Ann was referred to the DAC programme and has been enrolled in it since 1 August 2006. She is a core group member of the DAC choir, performing with the team in many SPD events, including the SPD Charity Show. Having found a safe haven with the DAC, she enjoys the community there. The DAC team is constantly helping Yu Ann with building her confidence and hopes that she will be able to manage her anxieties and be more independent in the days to come.

### REHABILITATION CENTRES

We operate two **SPD Rehabilitation Centres** (RCs) at SPD Ability Centre and SPD@Toa Payoh to provide step-down care for persons with disabilities. Through physiotherapy and occupational therapy, we help our clients regain self-reliance and integrate back into the community.

### Manomoney D/O Subramaniam SPD Rehabilitation Centre Client

Manomoney D/O Subramaniam is passionate about cooking and she used to teach cooking at a community centre before undergoing a total right knee replacement. Besides the surgery, Manomoney was also nursing an ankle injury. The once cheerful and active 67-year-old started feeling unhappy and frustrated as she couldn't move around without the use of walking aids. Manomoney was referred to SPD for physiotherapy and occupational therapy twice a week to help her get back on her feet. SPD's therapists worked patiently with her, motivating her to carry out the prescribed exercises at home. As she got stronger, Manomoney's spirits also lifted and she worked harder in the hopes of going back to her previous active lifestyle. Manomoney is much happier today because she is able to walk independently now. Her heart is set on visiting her family overseas and then going back to work.

### SPECIALISED TRANSPORTATION

To help clients who are unable to use public transport due to their disabilities or route inaccessibility, we provide a dedicated two-way transport service using specialised vehicles to our centres. Transport fees were heavily subsidised for clients.

### ASSISTIVE TECHNOLOGY

We believe assistive technology (AT) is a powerful enabler that could help individuals with disabilities overcome their physical limitations and help them lead a more meaningful and enriching life in school, at work and in the community.

Our Specialised Assistive Technology Centre (Specialised ATC) operates from Tech Able at the Enabling Village. Tech Able is a partnership between SPD and SG Enable to promote AT use.

Leonard Lu has cerebral palsy and a history of hydrocephalus, or swelling of the brain due to the build-up of fluid in the skull. Communicating through speech is a huge challenge for the 19-year-old. Assessed by the Specialised ATC for alternative and augmentative communication (AAC) intervention, Leonard was prescribed with AAC devices and given training which would aid him in daily communication. He is happy that AAC has given him a voice and enabled him to interact with others, especially on the phone with his father who travels regularly for work.

## Supporting clients and the whole family

### **CASE MANAGEMENT SUPPORT**

Under the Specialised Case Management Programme (SCMP), social workers and case management officers offer counselling, consultancy on disability issues and self-care management, and provide co-ordination and links to useful resources to support our clients and their caregivers. Clients served in the year largely had multiple issues such as lack of mobility independence and were in denial over their conditions.

Under the "Everywhere you want to be" pilot project, about 50 clients got to visit popular destinations in Singapore. The project aimed to reduce social isolation, improve social participation through outings and thereby increase the clients' quality of life.

### **CAREGIVER SUPPORT**



**9** orientation sessions were conducted for 117 EIPIC caregivers.

1,271 caregivers of children with special needs participated in activities and training, a two-fold increase from last year.

### Transition Briefings

Briefings were held for 149 caregivers whose children were graduating from EIPIC and transiting to the next stage of their academic journey.



A survey was conducted among EIPIC caregivers to understand their needs and stress points so as to improve our service delivery to caregivers.

### **Benson Tiew** SCMP Client

Benson Tiew, 39, was in a car accident in 2002 which resulted in a spinal cord injury. He was referred to SPD where he underwent vocational training and worked as a web designer in the now-defunct Multimedia Centre operated by SPD. While Benson has successfully moved on to open employment, he continued to be supported by our social workers over the years who rendered assistance, especially in applying for financial help for recurring purchases of assistive devices and replacement batteries for his motorised wheelchair. Their timely intervention and support have helped Benson and his family cope and move on with their lives.

## Governance

### IMPROVING TRANSPARENCY AND ACCOUNTABILITY

In the year, we continued to adhere to the Charities Act, the Code of Governance for Charities & Institutions of a Public Character and regulations issued by the Charity Council, reporting regularly to the Ministry of Social and Family Development (MSF), Ministry of Health (MOH), National Council of Social Service (NCSS), Agency for Integrated Care (AIC) and SG Enable (SGE).

We have also begun on our journey to meet the requirements of the refined Code of Governance for Charities & Institutions of a Public Character issued by the Charity Council in April 2017.

Our Board of Management is made up of volunteers. Board members are not paid any remuneration or director's fees. They serve for two years upon election or co-option to the Board in accordance with the SPD Constitution which is its principal governing and constituting instrument. The current Board has been serving since August 2016 and in the year, continued to lead the organisation into its strategic and forward planning cycle for 2017 to 2020.

#### In between

election years, the Board continues to pursue its policy of active recruitment of Board members through means such as Board members' contacts and the organisation's networks. Board policy and SPD's bye-laws guide the Board on selection, recruitment and induction of new members. Board and Board Committee members have access to multiple learning opportunities and platforms including formal training, representation in focus group discussions and conferences. These help Board members add depth to their leadership in the organisation and contribute to sector and community knowledge. The Board undertakes selfevaluation through retreats, work plan sessions and Board assessment surveys at strategic periods in the year.

The Board's work is supported by four Board Committees. They are the Services Committee, Fundraising Committee, Human Resource & Remuneration Committee, and Audit Committee. These committees work based on terms of reference set by the Board which reviews these terms from time to time to ensure relevance and to maintain good governance.

### **RESERVES POLICY**

SPD continued to adopt a pragmatic approach while planning the organisation's reserves for the year. Our reserves level was maintained at no more than two years to ensure that it met the immediate needs of our clients and at the same time have sustainable resources to support people with disabilities through our various programmes and services.

As at 31 March 2018, SPD's reserves stood at about 7.3 months.

Our financial results and standings were regularly reviewed by our Board through financial performance updates, forecasts, a budgetary exercise and annual financial statements approval. This was to ensure that we had adequate reserves to fulfil our continuing obligations.

### CONFLICT OF INTEREST POLICY

All Board members and employees are required to comply with SPD's conflict of interest policy.
